The undersigned may also participate in any of these activities either as a participant, volunteer, extra chaperone or interested spectator.

In consideration of First Covenant's permission for my child's participation in the youth ministry program, I/we do hereby release and discharge First Covenant, its agents, officers and employees from any and all claims, demands, grievances, and causes of action of every kind whatsoever, including, but not by way of limitation, all liability for property damages and personal injury of every kind, nature or description arising or which may hereafter arise from my/our participation or my/our minor child's participation in the youth ministry program activities or our presence at such activity sites or travel related to said program.

I/we hereby indemnify and hold harmless First Covenant from any and all claims, demands and causes of action of every kind and nature arising out of my participation or my minor child's participation in the youth ministry program or out of my presence or my minor child's participation at such activity sites or travel related to said program.
